**Snake River School Plant Facilities Reserve Fund Levy**

"Shall the Board of Trustees of Snake River School District No. 52, Bingham County, State of Idaho, be authorized and empowered to levy a School Plant Facilities Reserve Fund Levy in the amount of Seven Hundred Fifty Thousand and no/100 dollars (\$750,000) for the first fiscal year beginning July 1, 2018 and continuing each year in the amount of Seven Hundred Fifty Thousand and no/100 dollars (\$750,000) for ten (10) years, for the purpose of allowing the District to acquire, purchase or improve school site or sites; to accumulate funds for and to build a school house or school houses or other building or buildings; to demolish or remove school buildings; to add to, remodel or repair any existing building; to furnish and equip any building or buildings, including all lighting, heating, ventilation and sanitation facilities and appliances necessary to maintain and operate buildings of the district; to purchase school buses; for lease and lease purchase agreements for any of the above purposes and to repay loans from commercial lending institutions extended to pay for the construction of school plant facilities; and to upgrade technology?"
