




BINGHAM COUNTY ORDINANCE 2017-07 – 3RD READING

The Commissioners met for the 3rd reading of Bingham County Ordinance 2017-07, An Ordinance Regarding Prohibiting the use of Tobacco or Electronic Cigarettes on School Properties, and Providing for an Effective Date. Idaho Code §50-902 states that that this Ordinance shall be read on three different days, two of these readings may be by title only. Chairman Carter read the Bingham County Ordinance 2017-07 by title as follows:

An Ordinance of the County of Bingham, State of Idaho Adding Section 07 of Title 2017, Regarding Prohibiting the Use of Tobacco or Electronic Cigarettes on School Properties, and providing for an effective date of this ordinance.

Ordinance 2017-07, An Ordinance Regarding Prohibiting the use of Tobacco or Electronic Cigarettes on School Properties in Bingham County. Commissioner Bair moved to approve Ordinance 2017-07. Commissioner Manwaring seconded. On Roll Call Vote; Chairman Carter – Aye; Commissioner Manwaring – Aye, Commissioner Bair – Aye. Ordinance 2017-07 was adopted as follows:

**BINGHAM COUNTY ORDINANCE
2017-07**

AN ORDINANCE OF THE COUNTY OF BINGHAM, STATE OF IDAHO, ADDING SECTION 07 OF TITLE 2017, REGARDING PROHIBITING THE USE OF TOBACCO OR ELECTRONIC CIGARETTES ON SCHOOL PROPERTIES, AND PROVIDING FOR THE EFFECTIVE DATE THEREOF.

BE IT ORDAINED BY THE BOARD OF COUNT COMMISSIONERS OF THE COUNTY OF BINGHAM, STATE OF IDAHO AS FOLLOWS:

SECTION 1: That Section of Title be added as follows:

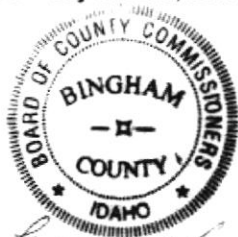
Use of Tobacco or Electronic Cigarettes Prohibited on School Grounds:

It shall be unlawful for all persons to use or consume tobacco products of any form, as defined in Idaho Code 39-5702(14), or electronic cigarettes, e-cigarettes, electronic cigar, electronic pipe, vape product or any other similar product name or descriptor, as defined in Idaho Code 39-5702(6), upon any school grounds within the County, including but not limited to the grounds of any public schools, private schools, charter schools, religious schools, or other places where minors are regularly present in an educational or athletic programs

A first violation of this section shall constitute an infraction and shall be punishable by a fine of \$100.00. Any person who pleads guilty or is found guilty of a violation of this Ordinance, who previously had been found guilty or has pled guilty to a violation under the same ordinance within the past five (5) calendar years, shall be guilty of a misdemeanor punishable by imprisonment in the County jail not exceeding thirty (30) days, a fine not exceeding five hundred dollars (\$500.00), or both such fine and imprisonment.

SECTION 2: That this Ordinance shall be in full force and effect from and after its passage and publication as provided by law.

STAFF MEETING

The Meeting was conducted by Chairman Carter.

Pledge of Allegiance: Chairman Carter

Minutes: There were no changes or corrections to the minutes for May; they were approved as written.

Special Presentation: A video about Patriot Field was shown.

Commissioners: Commissioner Manwaring explained that Idaho Code Title 31, Chapter 32, states that for copies of documents recorded in the Clerk's Office there is a fee of \$1 per page. Since most all departments have access to the recorded documents, there have been complaints from individuals that some offices charge for these documents and others do not. We need to be consistent throughout the courthouse and every office needs to be charging the public for these documents or the public should be getting the copies from the Clerk's Office.

Chairman Carter stated that the Commissioners signed an ordinance that was presented to them by the Bingham County Youth Coalition to prohibit tobacco use on school campuses.
